## SPEAKERS

**Carolyn Brown, DVM**, ASPCA Senior Director, Community Medicine. In her current role, Dr. Brown helps provide high-quality, high-volume spay/neuter surgeries, as well as basic and preventive care, to pets living in poverty and at risk of shelter relinquishment in New York City and Los Angeles. Her patients include privately owned pets, community cats and animals in the care of shelters, rescue groups and foster care networks. A graduate of Cornell University's College of Veterinary Medicine, Dr. Brown also determines and evaluates medical and surgical protocols.

**Aimee Christian**, ASPCA Vice President, Community Medicine. Aimee Christian joined the ASPCA in 2005 as manager of the mobile clinic program. Since then, she's overseen the growth of the Community Medicine department from two mobile spay/neuter clinics and a dozen staff members to a bicoastal team of over 100, with six mobile units and three stationary clinics performing more than 50,000 surgeries annually. With a background in education, Christian focuses on providing services to the community that keep pets in their homes and out of shelters.

**Stacey Evans, Esq.** is the Founder/CEO, of Stacey Evans Consulting, LLC. Stacey's expertise on hemp, marijuana, and FDA laws and policies help companies, veterinarians, and other stakeholders, understand the legality of using hemp and marijuana products in veterinary practices. 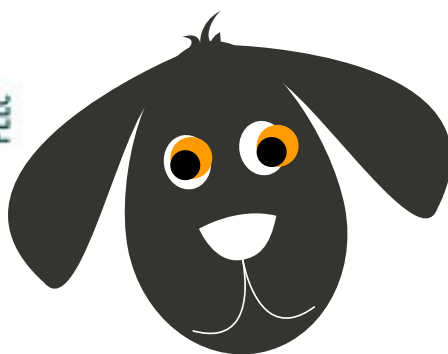
